Subject: The Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates)(List of Approved Doctors) Notification of 2012 (P.I. 234/2012)

I refer to the above subject and further to my Circular No.37/2011, regarding the issue of Notifications P.I. 347/2011 and P.I.348/2011, I wish to inform you that the Minister of Communications and Works of the Republic of Cyprus, in exercising his powers under Article 12 of *the Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates) Law of 2000, (Law 107(I)/2000), issued The Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates)(List of Approved Doctors) Notification of 2012 ,P.I 234/2012* (published in the Official Gazette of the Republic No. 4577, Supplement III(I), dated 29.6.2012).

Seafarers Medical Examinations in Cyprus should be carried out either by doctors in the private sector whose names appear in the following list of Approved Doctors or in Government General Hospitals (Nicosia, Limassol, Larnaca, Ammochostos, Paphos).


