Report of the Director-General

Sixth Supplementary Report: Electronic distribution of preparatory documentation for sessions of the Governing Body

- **1.** The Office invited all members of the Governing Body to take part in a trial distribution of documents in electronic format, in order to achieve the following objectives:
 - enhanced service through earlier reception of documents by members; and
 - reduction of printing and dispatch costs.

Fifty members accepted to participate in this test (29 English-language speaking, eight French and 13 Spanish).

- 2. The test was carried out between September and November 2005. An email message was sent every week informing these members of the list of new documents posted on the ILO web site. Paper versions of the documents were sent to all members in parallel.
- **3.** During the 294th Session (November 2005) of the Governing Body, a questionnaire was distributed to all members taking part in the experiment. This requested their feedback with a view to improved service. A reminder was sent in December 2005.
- **4.** Twenty-two members replied to the questionnaire. Responses indicated that they were satisfied to have gained access to documents before receiving the printed version, which was of assistance to them. Some members printed short documents from the web site. Full details on replies are given in the attached table.
- 5. Given the positive feedback, the Office has continued the test for the pre-session documents of the 295th Session, with account being taken of the suggestions that were given, such as an indication, in the notification email, of the full title of the documents that have been posted on the web site. It is intended to monitor the process further, with a view to presenting a proposed policy position to the November 2006 session of the Governing Body.
