TERMS OF REFERENCE

for

URBAN ENTERPRISE SURVEY IN POST-DISASTER SETTING

1. Background

On February 6, 2023, two devastating earthquakes, measuring 7.7 and 7.6 magnitudes, struck Pazarcık and Elbistan in Kahramanmaraş, Türkiye. These earthquakes are the largest to hit Türkiye in the last century and the most significant to strike the country's regions in hundreds of years. The most affected areas, which follow the south-eastern Anatolian fault line, include a population of 14,021,280 people and more than 1.5 million Syrian refugees. More than 50,000 people were killed in the earthquakes and around 107,000 were injured.

The earthquake had a significant impact on the lives of people in the affected areas, resulting in loss of life, displacement, and damage to homes and businesses. This has led to reduced income generation opportunities and economic hardship. Furthermore, the macroeconomic parameters, including inflation, recession, and income loss, are likely to affect both refugees and host communities in the aftermath of the earthquake. Therefore, given the potential long-term effects, there will be a greater need to strengthen the resilience of refugees and host communities in the earthquake region by promoting access to decent work and livelihood opportunities.

The International Labour Organization (ILO) plays an important role in supporting the recovery of enterprises (micro, small and medium-sized enterprises) after disasters. The ILO's role is to promote decent work, sustainable economic growth, and social justice, and it has specific programs and initiatives that support enterprises in disaster-affected areas.

Through the ILO's human-centred approach and inspired by Recommendation No.205 on Employment and Decent Work for Peace and Resilience as well as ILO's Standard Operating Procedures for crisis response on progress to help building back better, immediately after the earthquake, the ILO Türkiye Office started work to re-purpose and redirect the funds under the ongoing Development Cooperation (DC) projects to address the immediate needs and early recovery efforts, which are also in line with the ultimate objectives of the Projects.

Under this scope, the ILO Office for Türkiye is conducting several assessments to understand the situation in the earthquake-affected region from different labour market perspectives and propose corresponding interventions by supporting job creation and strengthening labour market institutions and constituents in the region.

Based on that, ILO Türkiye plans to conduct an urban enterprise survey under the scope of the "Evidence Generation to Support Post-disaster Recovery of the Labour Market in Türkiye" project to:

- Asses the current state of enterprises and recovery progress across various dimensions within target provinces,
- Identify key challenges and opportunities for business continuity and enterprise development,
- Evaluate the impact of external factors to determine how external factors, such as economic and labour market policies are influencing the enterprises and labour market dynamics,
- Support evidence-based policymaking for the recovery and development of the labour market in the affected areas,
- Inform constituents and the public about findings.



As ILO plays a critical role in supporting the recovery of enterprises after disasters by providing rapid assessments, financial and technical support, and creating employment opportunities for disaster-affected communities, the result of the assessment will shape the response of ILO in the region, especially in designing, planning, and providing assistance, including supports for (i) capacity building for enterprises, employer and business membership organizations and relevant government authorities, (ii) access to finance to help enterprises recover iii) recovery of supply chains for decent job creation. This assessment includes the number of affected businesses, the extent of damage to their premises and equipment, the number of jobs lost, and the skills and finances needed to rebuild the businesses and recover the supply chains. It is planned to reach to the gender disaggregated data (GDD) with a special focus on the current situation of the businesses led by women and/or number of women employees in the analysed enterprises and/or women dominated sectors, the enterprises' support for care responsibilities etc.

2. Scope of the Service

The objective of the Service is to conduct an urban enterprise survey to identify the current state of enterprises in terms of supply chains, human resources, financial situation, future prospects and availability of customers and physical assets and address their short and long-term needs in the disaster-affected areas, with a focus on human-centered recovery. Special focus will be given to the current socioeconomic situations and needs of the women employers and/or employees of the analysed enterprises.

Duties and Responsibilities

2.1. Activity 1 Desk Review

• Conducting a desk review of existing secondary sources, including any relevant government or international organization reports to analyse the pre-post disaster situation to understand the earthquake's impact on enterprises in the disaster-affected areas, and identifying the knowledge gap that should be covered by a novel enterprise survey.

2.2. Activity 2 Drafting Questionnaire, Survey

The service provider must develop two questionnaires by taking the details below into account: A two-staged enterprise survey will be devised to provide: 1) representative information on the extent to which local companies are operative and 2) the current state of human resources, physical assets, financial situation, supply chains and market access, and availability of customers.

The survey will also support generation of evidence on recovery efforts for enterprises, investigate how enterprises have adapted to the new environment, identify variances across sectors and/or geographic areas if available, as well as future prospects by providing recommendations on policy and institutional environment, business continuity and resilience for the enterprises. The survey findings will include gender disaggregated data.

- The first stage will be devised as a limited census whereby 9 neighbourhoods in the centres of the most affected provinces of Gaziantep, Hatay, Malatya, Kahramanmaraş and Adıyaman provinces will be visited.

These neighbourhoods will be chosen based on commercial/industrial density (low, medium, and high) and damage extent (low/medium/high). The **indicative** list of the cities and districts where neighbourhoods will be selected is given below:

- ✓ Gaziantep: Central Districts
- ✓ Malatya: Battalgazi and Yeşilyurt
- ✓ Kahramanmaraş: Onikişubat, Dulkadiroğlu,
- ✓ Hatay: Antakya, Defne, İskenderun,
- ✓ Adıyaman: Central District

When these two criteria are combined, 9 possibilities (neighbourhoods) will be identified (for instance low damage and medium commercial activity (*1a) as shown in the table).



commercial/industrial density	damage extent

In each neighbourhood, it is expected to survey with a minimum of 50 enterprises, totalling 450 enterprises per province for a total of 2250 workplaces surveyed across the provinces.

- **The second stage** will consist of a survey answered by businesses identified in the first stage, chosen from those that consented during the first stage.

Upon obtaining consent in the first stage, enumerators immediately conduct the detailed survey with the business. The enumerators should have a minimum target of completing surveys with 15 businesses for each neighbourhood. Real-time tracking of surveys completed should be followed. A central coordinator monitors the overall progress and informs enumerators when the target of 135 surveys per province is close to being met or has been met. Enumerators report their progress regularly and adjust their efforts based on feedback from the central coordinator. If obtaining consent in certain neighbourhoods proves challenging, increasing the number of neighbourhoods surveyed or reallocating survey targets to other neighbourhoods can be a viable option.

In total 135 businesses per province to be chosen from the first stage. It is expected to have a detailed survey of a total of 675 (135*5) enterprises in selected areas. A soft quota of %20 women-owned enterprises will be applied so as to ensure sufficient data for the analysis.

It should be noted that companies in Gaziantep are not expected to have had severe damages; the rationale for interviewing them is to find out whether they have been affected indirectly in terms of increased demand as it may be covering up for labour, goods and services shortages in neighbouring provinces and having a critical role in the revitalization of the regional supply chain.

Based on the above, the responsibilities under the activity:

- Prepare a draft questionnaire in cooperation with the ILO Office,
- Utilize statistical sampling to select a representative sample of the affected enterprises based on the above information and ensure that the sample size is adequate to draw meaningful conclusions in line with the aim of the Survey.
- Ensure the research design includes a diverse range of enterprises, including those owned by women and migrants.
- Collaborate with local stakeholders especially Chambers, Business Associations, NGOs, other international organizations to enhance data collection.
- Establish a team of enumerators with sufficient number and local knowledge/experience of the target provinces and provide necessary training to conduct such survey with accuracy, reliability and ethical conduct of the data collection processes.
- Conduct a survey with utilized samples in the target provinces.
- Obtain informed consent from all respondents participating in the survey. It should involve clearly explaining the purpose, scope, and nature of the survey to the participants, ensuring they understand their rights, the voluntary nature of their participation, and the confidentiality measures in place to protect their data. The service provider must also ensure that participants are aware that they have the right to withdraw their consent at any stage without any repercussions. This process should be carried out with the utmost respect for the participants' autonomy and privacy, adhering strictly to ethical standards and legal requirements. The service provider's adherence to these protocols is essential in maintaining the integrity of the survey and the trust of its participants.
- Analyse the data collected using appropriate statistical and analytical techniques.



2.3. Activity 3 Key Informant Interview, Reporting and Presenting the Findings

- Identify key informants, such as target key social partners including local government institutions, trade unions, employers' and business membership organizations, chambers, and relevant NGOs to get insight into the current situation and needs of the enterprises in target provinces.
- Develop interview questions and conduct minimum 15 of key informants' interviews (minimum 3 interviews from each province) via phone for validation and get insights on the topic
- Send the collected raw data from the four provinces to the ILO for appraisal.
- Clean and check the raw data for consistency. Submit the cleaned dataset to the ILO for appraisal.
- Prepare a comprehensive report based on the findings in English and in a clear and concise manner.
- Present the findings in the validation meeting.

The indicative outlines of the Report shall include the following sections:

- **1. Executive Summary**: A summary of the key findings, recommendations, and actions needed.
- 2. Introduction
 - Background information on the earthquake and its impact on the region
 - Purpose of the Report
 - Refer to and assess government policies/legislation, ILO Conventions about the topic, relevant policy objectives specified in national and provincial development plans

3. Methodology

- Overview of the assessment process
- Description of data collection methods (e.g., surveys, interviews, site visits)
- Limitations, assumptions of the assessment

4. Findings

- Overview of the enterprises in the affected region
- Key findings on the extent of damage and losses suffered from various dimensions.
- Analysis of the impact on different types of enterprises (e.g., microenterprises, small and medium-sized businesses), on different sectors
- Special consideration will be given to;
 - Employment and Skills: The impacts on employment levels, job losses, and potential displacement, skills shortages, mismatches and training needs, state of workers' accommodation and commuting, individual or institutional solutions.
 - Economic impact and income security: the impact on income loss, financial vulnerability, and access to social safety nets.
 - Decent work, changes in working conditions, safety and health, and compliance with labour standards.
 - Recovery progress, good practices, local collaborations, global supply chain collaborations (if any)
 - Business environment and supply chain disruptions,
 - Available institutional support mechanisms including public, chambers, and other.
 - Future prospect in terms of business continuity, development, employment, etc.
 - Specific measures for women's access to employment including providing accessible care services.

- Samples of the previous work demonstrating writing skills and previous work in socioeconomic fields

The Bidder should ensure that the research team will work actively throughout the research. ILO reserves the right to terminate the contract if otherwise is observed.

4.3. Evaluation Criteria

• Quotations will be reviewed and evaluated by an RFQ Evaluation Panel to determine compliance with the requirements specified in the RFQ.



- The proposals will be evaluated according to the criteria described below:
 - i. **Eligibility Check**: The bidders will be evaluated concerning the eligibility criteria provided in the ToR. The bidder's proposal that fails to meet one of the eligibility criteria will not be considered for further evaluation.
 - ii. **Technical Evaluation:** A technical evaluation will be conducted to measure the bidders' technical responsiveness and to ensure full compliance with the requirements of the assignment. The proposals will be evaluated based on the Technical Evaluation Criteria below.
